### **MISSOURI ELECTION LAW 80.050**

#### **Trustees – qualifications:**

- Attained the age of Twenty-one (21) years,
- A resident and registered voter of the voting precinct (High Ridge 1) of Village of Parkdale, Township of the County of Jefferson and the State of Missouri,
- Citizen of the United States of America,
- A resident of the State of Missouri and Village of Parkdale for at least one (1) year next preceding the election.
- Comply with Section 115.306 and 115.349 of Missouri Statutes.

### **VILLAGE OF PARKDALE ORDINANCE #9**

#### **AN ORDINANCE REGULATING ELECTION OF TRUSTEES AND FILING FEE**

Be it ordained by the Board of Trustees of the Village of Parkdale, MO. As follows: that any qualified voter of the Village of Parkdale desiring to announce for election to the Board of Trustees from the Ward which he resides shall be entitled to do so by filing such a notice with the Village Clerk and paying a filing fee of one dollar (\$1.00).

### **MISSOURI ELECTION AUTHORITY AND CONDUCT OF ELECTION SECTION 115.306**

No Person shall qualify as a candidate for elective public office in the state of Missouri who has been found guilty of or pled guilty to a felony under the federal laws of the United States of America or to a felony under the laws of this state or an offense committed in another state that would be considered a felony in the state.

Any person who files as a candidate for election to a public office shall be disqualified from participation in the election for which the candidate has filed if such person is delinquent in the payment of any state income taxes, personal property taxes, municipal taxes, real property taxes on the place of residence, as stated on the declaration of candidacy, or if the person is a past or present corporate officer of any fee office that owes any taxes to the State.

Each potential candidate for election to a public office, except candidates for a county or city committee of a political party, shall file an affidavit with the department of revenue and include a copy of the affidavit with the declaration of candidacy required under section 115.349.

**First day of candidate filing 8:00AM December 5, 2023. The closing filing date shall be 5:00 PM December 26, 2023.**

Note: Residents of the Village of Parkdale, MO are exempt from filing Financial Disclosure Law (Operating budget is under \$1 million dollars)
